PAUL G. NITTOLY is Of Counsel in

He received his bachelor's degree from Rutgers University in 1970 and his J.D. from New York Law School in 1973. He lectures and writes on a variety of legal topics and was a member of the editorial advisory board of the Corporate Criminal Liability Reporter. His publication, "Environmental Criminal Cases: The Dawn of a New Era," appeared in the Seton Hall Law Review, Volume Twenty-One, Number Four. He is also the author of two book chapters in the text Readings in White-Collar Crime.
