Selects Raymond M. Brown, Esq. for Francis X. Dee Award**

*Newly Established Award Honors One of the Nation's

MORRISTOWN, NJ – The New Jersey Fellows of the American College of Trial Lawyers (ACTL), recently announced that it has selected Raymond M. Brown, Esq. as the first recipient of the Francis X. The award will be presented at The New Jersey Fellows of the ACTL annual reception and dinner on February 3rd.

The newly establish award celebrates the life of Francis X. Dee, an ACTL Fellow member who during his 47-year legal career, was broadly recognized by his peers as a trial lawyer who exemplified the profession's highest ideals. Francis (Frank) Dee, who served as a Partner at Morristown-based McElroy, Deutsch, Mulvaney & Carpenter, LLP, was considered one of the nation's most respected employment attorneys.

The award recipient, Raymond M. Brown, currently serves as a Partner in the litigation department at Greenbaum, Rowe, Smith & Davis LLP, and is widely regarded as one of New Jersey's most prominent trial lawyers for white collar defense and corporate & international human rights compliance. Mr. Brown, a long time ACTL Fellow, has earned an extensive list of professional accomplishments, honors and recognitions over his four decade long legal career, and has also served as co-host of the Emmy Award winning "Due Process," which has been broadcast on New Jersey public television for 19 years.
