Mr. Aumenta routinely litigates in state and federal courts in New Jersey, New York and Pennsylvania. His recent cases include the following:

- Successfully obtained summary judgment on behalf of lending and mortgage servicer clients in numerous contested residential and non-residential foreclosures in New Jersey and New York, involving issues related to standing, statutory violations, fraud and misrepresentation, and predatory lending, among many others.
- Successfully represented lending and mortgage servicer clients in the defense of numerous claims, assessments, fines, and other violations issued by public bodies, including the New York Environmental Control Board.
