He served on the Board of Directors of Inter-Continental and was chair of the company's Life Safety and Security Committee and a member of the Development Committee and the Pension and Benefits Committee. Prior to joining Inter-Continental, Mr. Pucciarelli served as Vice President and Counsel to Grand Metropolitan (U.S.) and its publicly owned (NYSE) predecessor, Liggett Group, Inc. He is a Director of Skytop Lodge Corporation in Skytop, Pennsylvania, and a consulting member of Cayuga Hospitality Associates.

He has taught International Business Law as an adjunct professor at the Fordham University Graduate School of Business, and was member of that school's Advisory Board (1996-2004). He is a member of the Cheyney University of Pennsylvania Hotel, Restaurant & Tourism Management Board (2014-present).

He is Chair of the New Jersey State Bar Association Aviation Law Committee (2018-present). He has served as Chair of the Hotels, Restaurants and Tourism Committee of the Association of the Bar of the City of New York (2001-2004) and as Chair of the Aeronautics Law Committee of the Association of the Bar of the City of New York

(1998-2001). He is a Director and past President of the Hospitality Industry Bar Association.

Mr. Pucciarelli is fluent in Russian. He is an instrument-rated commercial pilot, an FAA certified advanced ground instructor and an aircraft owner. He is President of the Mid-Atlantic Pilots Association. He is Vice President and a Trustee of the New Jersey Aviation Hall of Fame and Museum.
