<u>Davis v. Brickman Landscaping, et al.</u>, 219 N.J. 395 (2014) (expert testimony required to establish standard of care applicable to fire sprinkler inspectors – standard of care advanced by Plaintiff's expert constituted an inadmissible net opinion).

<u>Hisenaj v. Kuehner</u>, 194 N.J. 6 (2008) (affirming trial counsel's admission of biomechanical engineer's expert testimony where defense expert provided an adequately reliable scientific foundation for opinion).

Herring v. Kettleman's Bagels Deli & Grill, et al., A-2465-15T1, (App. Div. 2017) (affirming grant of summary judgment to defendant where plaintiff relied on an impermissible net opinion of liability expert).

White v. Getty Petroleum Marketing, Inc., et al., A-3398-13T3 (App. Div. 2016) (Appellate Division held no duty of care owed by gas station operator to prevent gang related shooting on property).
